BACKWOODS FEST RULES & REGULATIONS

- 1. This is a Juried and Invitational Show. The promoters have the right to reject or accept any vendor or craft.
2. Festival is held RAIN OR SHINE, so have appropriate rain coverage for your booth and you. No early tear-downs or leaving the show early even if it rains. Show hours are posted and advertised and you must be open entire show hours.
3. Shelters/booths /tents will be your responsibility. Damage to any booth left on FEST grounds is the sole responsibility of the vendor/owner.
4. Construction of your booth must stay with the BACKWOODS theme. NO plywood, luan, vertical v-groove siding, aspenite, particle board or peg board. Please contact promoters before building.
5. WHITE TENTS ONLY. No blue, ivory, only WHITE. No dining tents, lawn gazebos.
6. ABSOLUTELY NO SPRAY OR CHEMICALS OF ANY KIND IS PERMITTED ANYWHERE IN THE BACKWOODS ( ie: INCLUDING WEED KILLER, ROUND UP) DO NOT MOW OR WEED-EAT.
7. DO NOT CUT ANYTHING IN YOUR BOOTH, OR NAIL INTO TREES!
8. All items for sale must be HAND-CRAFTED. NO BUY-SELL ITEMS ARE ALLOWED. A list of all items to be sold must be supplied on your application. ALL MUST send pictures even if a past vendor.
9. No items other than those approved will be allowed to be sold. This is a family FEST-any objectionable items on display will result in immediate removal from the FEST without refund.
10. Only ONE exhibitor per booth.
11. Your exhibitor pass will be your only access to the Festival grounds after 7:00 am all three days of show.
12. Your booth fee includes TWO exhibitor wristbands. Additional wristbands can be purchased at the info booth for additional workers you may have.
13. NO radios, televisions allowed. NO ALCOHOLIC BEVERAGES permitted.
14. Set up will be Monday Sept. 10th through Thursday Sept 13th. All booths must be in place by dusk Thursday the 13th. Traffic may have to be controlled based on weather conditions. All vehicles MUST be off show grounds by 7:00 am all three days. Gates will close at 6:45. Exhibitors must park in the designated exhibitor parking area.
15. Any crafter or their workers defacing FEST property in any way will be fined by law and asked to leave immediately.
16. NO raffles or other solicitations permitted.
17. Exhibitor is responsible for collection and payment of sales tax.
18. NO smoking in the woods.
19. A charity auction will be held on Saturday at 2:00 to benefit a local non-profit charity. It is expected that you donate one item. A tax deductible receipt will be available upon request from the organization.
20. NO electric is available and NO generators are allowed.
21. Deadline for application is April 1, 2018 or until full. After April 1 use after April 1 pricing.
22. NO REFUNDS WILL BE MADE ONCE APPLICATION IS ACCEPTED. NO EXECPTIONS.
23. Send both pages of application completed with your check for booth space and PICTURES to the address listed on contract. Checks will not be cashed until you are approved. No refunds after you have been accepted.
